MODIFICATION OF THESE TERMS OF USE

BBN Inc. reserves the right to change the terms, conditions, and notices under which Sites/Services are offered, including but not limited to the charges associated with the use of hosting Sites/Services. Written notice of any changes will be provided at least thirty (30) days before the change takes effect.

FTP AND HOSTING

Transmission, storage, or presentation of any information, data or material which includes, but is not limited to: copyrighted material, material that is threatening or obscene, hate-material or propaganda, material that is "adult only" content, is strictly prohibited. Pornography and sex-related merchandising is prohibited on any BBN Inc. server. This includes sexual content, direct links to adult content or promotion of any illegal activity or content.

BBN Inc. will be excluded from any claims, legal or otherwise, resulting from improper use of your hosting account. BBN Inc. reserves the right to review and remove your entire site if any material is found unacceptable und BBN Inc. policies or the Laws of the United States.

Each account comes with an allotted amount of server space (10mb) with the option to purchase space if needed. Any account exceeding the allotted amount will be subject to additional fees; otherwise BBN Inc. reserves the right to remove the site.

Any customer found accessing, or to have accessed, any information that is not of their own will have their account terminated with no refund. This includes, but is not limited to, accessing data not intended for the customer, logging into a server or account the customer is not authorized to access, password cracking , or probing the security of servers or networks. DOMAIN NAME REGISTRATION

Domain names are registered and monitored through BBN Inc and it's registrar will have BBN Inc. contact information. Any domain(s) not registered through BBN Inc. and it's registrar are not the responsibility of BBN Inc. In this case, you are responsible for the renewal of your own domain(s).
